#### The Ontario Autism Program

Applied Behavioural Analysis (ABA), Early Intervention Programs, Entry to School, and Foundational Family Services.

#### **Childcare and Essential Childcare Support**

Early Learning Resource and our inclusive childcare centre, H.S. McLellan Preschool.

We are also proud to partner with Word Play to provide all Infant Hearing screening in Algoma as well as support the Infant Hearing and Blind-Low Vision Program.





#### Focus on Families

THRIVE continues to center all of its services around our families. The increased usage of virtual care has meant that we are able to support families when and how they choose. This blended model of service which includes in-person and virtual sessions has meant less weather related cancellations and more efficient services in line with best practice. We continue to embed coaching in everything we do, as we have learned that family engagement and involvement in their child's therapy leads to the best outcomes. We are committed to ensuring all of our staff are trained in Solution Focus Coaching. This is a model that is strengths based and familycentred, two philosophies that are the foundation of all the work we do. Over the past year we have continued to arow in our educational offerings to families. This includes new foundational family services through our OAP program, a new evening educational series in our SLP department and a library of easily accessible videos on our Youtube Channel, with plans to add more.

Our Family Advisory Committee continues to be a priority for us at THRIVE, and as we move back to in-person services, we look forward to renewed energy for this group of important advisors.

#### Focus on Youth

This year we created and facilitated a virtual group for youth with Fetal Alcohol Spectrum Disorder (FASD) or suspected FASD. We provided all the materials delivered to their door to ensure they felt engaged and had fun. This was a collaboration with Algoma Family Services and a part of funding we received through the Health Nexus Grant. We have continued to meet virtually with the Teens on The Move and were delighted to be able to run one session in-person as COVID restrictions allowed.



#### **Enhancing Services and Collaborative Opportunities**

THRIVE is committed to continuously improve and offer the best family-centered services to families. Over the past year, we have further focused services in our departments, to ensure we have clear pathways and service flow so we can see children when they need it most. In order to do this, we have created and strengthened our clinic model of service. This is a needs based, focused model that allows us to address a specific goal the child and family needs support with. We began to deliver the Infant Hearing Screening Program for all of Algoma. Through this program, we have developed a strong partnership with the Sault Area Hospital which has enabled us to successfully screen babies with long hospital stays who may have been missed otherwise.

We launched our new process for Respite in Algoma. As THRIVE now receives all the funding for respite, have been able to streamline the process and ensure all qualifying families have access to respite funds. Over the past year we have successfully eliminated the waitlist and created more equitable access to respite supports. The pandemic has continued to make it challenging for families to use their respite funding, but we are hopeful that this upcoming year; as restrictions ease, more families will be able to secure workers and feel comfortable having their children out in the community. We continue; as a group of children's service organizations, to be committed to a common intake process. This year we worked together and updated the Intake Package. This collaboration means that families only have to tell their story once while we gather the information needed by all organizations. This helps to make the process of moving from one organization to another: seamless for our families.





#### **School-Based Rehabilitation**

This year continued to be one where we had to be flexible in our service delivery and pivot when necessary. We successfully launched a pilot program in some of our specialized classrooms. Together; with the School Boards, we chose two classrooms where we had a large number of clients. We then assigned a team of therapists to the classroom itself instead of to the individual clients. Therapists then visited the class and provided suggestions and guidance to the professionals in the classroom. We also had a therapy assistant regularly in the class to provide intervention to the entire class. This model meant that one therapist would know all of the children and was readily available to answer the staffs questions. As well, it enabled our therapists to provide therapy right in the class; meaning that they were also teaching and training the staff simultaneously. This also meant there wasn't the same need to pull children from the class or have meetings with teachers outside of class time. Our hope is to bring this model to similar types of classes across all boards. We also launched an updated needsbased referral form for our School-Based Services this year. This enabled the school staff to provide more anecdotal information in each of the sections, and has given our therapists a clearer picture of all of the child's needs. We have received positive feedback on these new forms.



#### **Ontario Autism Program**

One of our key areas of focus during this last year has been the Ontario Autism Program. THRIVE provides supports in Behavioural Treatment services and supports in Algoma. We worked diligently in partnership with Child & Community Resources over the last year to ensure that these services are preserved in Algoma and delivered by trained, professional staff. THRIVE has played an

active role in the delivery of Foundational Services through the Northern Collaborative. Foundational family services aim to build a family's capacity to support their child's learning and development. THRIVE also launched our Fee for Service model; currently offering ABA Services to children and families receiving funding through the Ministry of Children, Community and Social Services.

THRIVE continues to develop services for children, youth and families for the new needs-based Ontario Autism Program.

#### **Preschool Programs**

THRIVE's Early Learning Resource (ELR) Consultants have serviced 67 children in the City of Sault Ste. Marie and 53 in the Algoma District. With the guidance of Algoma Public Health, the Early Learning Resource Consultants began to incorporate virtual visits with outdoor visits and slowly moved to providing Face-to-Face visits in Early Learning & Child Care Programs across the district of Algoma. This progression started in May 2021. Since in-person visits started again, they have been so valued and many licensed Child Care programs are requesting our consultants provide as much training as possible to their Early Childhood Educators. They have really missed such connections with the consultants during the last two years, and return to in-person has supported the many children in their programs with diverse abilities. H.S McLellan preschool has been working very hard to create relationships with families that are once again entering our preschool to drop and pick up their children. Many of our Covid-19 procedures in Child Care changed in March 2022. Since this change, the educators are in the process of implementing a 'hiMama' communication platform which will engage parents in the process of their children's daily learning, play, and development. This platform has already been adopted by many local childcare programs and both the families & educators are looking forward to it. We are so very proud of our ELR and Preschool team here at THRIVE; their dedication, flexibility, and determination to support children and families is admirable.




#### Speech Language Pathology

#### Debbie Francis—Health Records Coordinator


